- We recommend heavier stock (24# or more) on single page inserts. They are inserted by machine and single sheets on 20# (copy paper) stock may double up.
- Inserts must be delivered to our office at 327 Irving Avenue, Port Chester, NY 10573 at least 10 days before date of insertion in the paper. (i.e. must be to us by the Wednesday morning before the following Friday's newspaper.) Later delivery will incur a surcharge of at least \$70. Even when paying surcharge, inserts must be to us no later than Tuesday for that Friday's newspaper.
